



# MATERIAL RELEASE FORM

1. 2. I hereby grant Filmmaker and the 10dfc, INC ("10dfc") (together referred to as the "Producer") the unchangeable permission to incorporate the Material, in whole or in part, including any segments or images it contains, into the Short. This permission includes the exclusive right to use and make use of the Material (once incorporated into the Short) in all forms of media, current or future, and in any language, anywhere in the world, for an indefinite period. This utilization encompasses, but is not confined to, television, the Internet, DVDs, books, merchandise, and all associated marketing, advertising, and promotional activities related to the Short, the Entry, 10dfc, and/or any sponsor of 10dfc and/or the Entry. The Producer retains the authority to modify or adjust the Material at its own discretion. Moreover, the Producer may, at its discretion, provide appropriate recognition to me for the use of the Material in the Short and any related purposes.
3. I hereby confirm that I possess the requisite rights to grant the Producer permission for the use of the Material, without needing approval from any third party. I also affirm that the Material does not infringe upon any copyrights, nor does it violate any rights of publicity, privacy, or any other rights held by individuals or entities. I understand that the Producer is not obligated to use the Material. I agree to indemnify and hold harmless the Producer, including its officers, directors, shareholders, employees, agents, and representatives, from any liabilities, losses, claims, demands, costs (including reasonable attorneys' fees), and expenses that may arise due to any breach or alleged breach of the representations and agreements made above. I also commit to refraining from making any claims against any party regarding the exercise of the granted permissions. I acknowledge that in the event of a breach by the Producer or any third party, any resulting damages will be limited to compensatory monetary relief and will not include punitive or consequential damages. I understand that my remedies, if any, will be restricted solely to seeking compensatory damages in a court of law. I acknowledge that I do not have the right to terminate or rescind this Agreement or any granted rights, or to prevent the Entry, exhibition, or exploitation of the Short or any related rights. Additionally, I acknowledge that any breach does not warrant the termination of my obligations as outlined in this agreement.
4. I commit to promptly and effectively complete and provide, or ensure the completion and provision to the Producer, any supplementary documents that the Producer deems essential to establish its rights. Through this agreement, I hereby designate the Producer, or its chosen representative, as my unchangeable attorney-in-fact, empowered (but not obligated) to draft or finalize any such documents and to sign them on my behalf, or to secure the execution of said documents by suitable parties.
5. Producer holds the right to pursue injunctive measures, along with other potential actions, should any breach occur concerning the assurances, guarantees, and commitments I have made in this document. Producer is also entitled to independently transfer and license this agreement, along with its associated rights and remedies, in full or in part, without requiring my explicit approval. This Agreement is binding and advantageous to the respective affiliates, successors, licensees, assigns, heirs, and representatives of the parties involved. It constitutes the comprehensive understanding and pact between the parties regarding the subject matter presented here, and any modifications must be formally written and signed by all parties involved. 10 Day Film Contest Release Form
6. I grant Producer the specified rights as mentioned above, with a clear awareness that Producer may invest substantial resources based on this reliance. Producer also maintains the option to decide against using the Materials at any point, in which scenario both parties will be relieved of any responsibilities outlined in this agreement.
